Five Tips for Managing Behavior

"What can I do about challenging behaviors?" This is a common question asked by child care professionals across the state. Fortunately, the Virginia Infant & Toddler Specialist Network has some suggestions. While managing challenging behavior can be a difficult task for early child care educators, establishing a positive and nurturing environment that promotes healthy development and teaches appropriate behavior is important. While no single solution will work for all infants and toddlers, here are five tips that may help:

#1 Establish a Routine: Infants and toddlers thrive on routines, providing them with a sense of security and predictability. A consistent daily routine helps infants and toddlers understand what is expected of them and reduces anxiety. Create a schedule that includes regular mealtimes, nap times, play times, and bedtime. Stick to the routine as much as possible and encourage parents and caregivers to help during weekends or vacations; this can help infants and toddlers feel more secure and confident in their surrounding environment.

#2 Set Clear Boundaries:It is essential to set clear boundaries for infants and toddlers to understand what behaviors are acceptable and what are not. Use simple language and age-appropriate explanations to communicate rules and expectations. Be consistent in enforcing these boundaries, as inconsistency can confuse the infants and toddlers. Reinforce positive behaviors while redirecting or gently correcting challenging behaviors.

#3 Provide Positive Reinforcement: Positive reinforcement is a powerful tool for managing behavior in infants and toddlers. Acknowledge good behavior when it is displayed. Use specific language to describe the positive behavior, such as "You shared your toy with your friend. That was very kind!" This helps infants and toddlers understand what they did well and encourages them to repeat the behavior.

#4 Redirect Negative Behavior: Infants and toddlers often engage in developmentally appropriate behaviors that may not be desirable or safe. Instead of punishing or scolding them, try redirecting their attention to more appropriate activities or objects. For example, if a toddler is throwing toys, gently take the toy away and offer an alternative activity like stacking blocks or playing with a puzzle. Redirecting their focus will help them learn appropriate ways to express themselves.

#5 Model Good Behavior: Infants and toddlers learn by observing and imitating the behavior of adults and older children around them. It is crucial to model good behavior and be a positive role model for them. Show kindness, patience, and respect in interactions with others, including the infants and toddlers in care. Use polite language, share, take turns, and demonstrate problem-solving skills. When young children see positive behavior consistently modeled, they are more likely to adopt those behaviors themselves.

In conclusion, teaching appropriate behavior to infants and toddlers requires patience, consistency, and a nurturing environment. By establishing routines, setting clear boundaries, providing positive reinforcement, redirecting negative behavior, and modeling good behavior, caregivers can help promote positive behavior of the infants and toddlers in their care.

- ITBCs offer mentoring, parent education, technical assistance, and intervention strategies.

Early Childhood Mental Health Consultants (ECMHCs) ECMHCs work throughout Greater Richmond, Charlottesville, Albemarle County, and virtually throughout the state as needed.

- ECMHCs offer in-person, virtual, and hybrid services.
- ECMHCs help early childhood teachers promote healthy socialemotional development of children from birth to age five.
- ECMHCs provide coaching on practices to improve children's social and emotional development in a classroom or learning environment.
- Consultation can include resources to help children express emotions, form healthy relationships, and regulate their feelings with the support of an adult.
- In addition, ECMHCs work with families who may benefit from extra support to foster children's social-emotional skills at home.
